The particular concepts to be defined are derived from the title and main headings of the assignment. To <u>define</u> a concept means to state precisely the meaning or essence of the concept.

- Drug trafficking

#### Body

The body of the assignment consists of a discussion of the subject according to the guidelines provided in Tutorial Letter 101 for the specific assignment. Formulate your own headings and subheadings. A comprehensive discussion should have been provided on the following information:

- South Africa plays a multifaceted role in drug trafficking
- South Africa has a major consumer market
- South Africa tranship the drugs that has a small consumer market
- South Africa not only smuggles drugs (gemstones, ivory, abalone, weapons, rhino horn etc.)
- Nigerian drug traffickers capitalise on the vulnerability of South African borders
- South Africa is an attractive country for drug syndicates (unemployment, political instability etc.)
- After apartheid, South Africa invited international investment and trade
- South Africa had no formal controls, had no currency reporting requirements, had poorly trained law enforcement officials etc.
- Concerns were raised for the rapid growth of organised crime
- The distribution of drugs within South Africa is closely related to street gangs
- A transformation in the patterns of drug consumption occurred since the apartheid years
- The extent of syndicate drug trafficking is escalating
