#### External causative factors

- -Opportunity: to reward innovative ideas and outstanding results provide opportunity
- -Predisposition: predispositions are created if companies have poor ethics and controls

#### Internal causative factors

- -Individual characteristics: low intelligence quotient and poor self-control
- -Moral argument: compare individuals with high and low levels of cognitive moral
- -Machiavellism: Provide the meaning and discuss a number of characteristics

- -Discuss the three variable that explain the misdemeanours of corporate criminals
