### **3 ASSIGNMENTS AND ADMISSION TO THE EXAMINATION**

---

For the module ILW1036 you have to submit **one compulsory assignment** in order to obtain **admission to the examination** for the **second semester**. The closing date for this assignment is **22 August 2008**. (See Tutorial Letter 101/2008, 7.2-7.5, pp 9-10.) **If you do not submit this compulsory assignment, you do not have admission to the examination.**

The compulsory assignment counts a total of 20 marks. Your mark out of 20 will be adapted to a mark out of 10. This mark out of 10 is your semester mark. Your semester mark will constitute 10% of the final mark for ILW1036. Your semester mark will only be taken into account if you obtain an examination mark of at least 40%.

Once again study Tutorial Letter 101/2008, 8.5-8.7, pages 11 to 13 regarding admission to the examination, your year mark, as well as the supplementary examination and the year mark.

## 4 EXAMINATION! EXAMINATION! EXAMINATION!

### 4.1 Date and time of the examination

According to the **provisional examination timetable** the examination for ILW1036 will take place on **20 October 2008** from **14:00 to 16:00** at the different examination centres. **Please check this information** when you receive the **final examination timetable**. The Examination Section will post the final examination timetable to all registered students in September 2008.

### 4.2 Sections in Tutorial Letter 501/2008 that you do not have to study in detail

**PLEASE NOTE** that you are **not expected to study** and **memorise** the following in **Tutorial Letter 501/2008 in detail**:

- (1) the **contents** of The Choice on Termination of Pregnancy Act 92 of 1996 (in study unit 6)
- (2) the **contents** of the Bill of Rights (in study unit 8)
- (3) the **contents** of any court cases (eg *S v Makwanyane* in study unit 6; and *Naude and Another v Fraser* in study unit 6)
- (4) **full** references of acts and cases

**HOWEVER**, you are expected to **study** the **activities** and **feedback** that are given on The Choice on Termination of Pregnancy Act 92 of 1996, the Bill of Rights and the court cases.

### 4.3 Use of language in the examination

Please do not make use of telegram style or *sms* style when you answer the questions in the examination. Please use complete and comprehensible sentences in your answers, as well as punctuation.

### 4.4 Previous examination papers

**Previous examination papers are not available to students.** However, in this tutorial letter we provide you with the exact format of the examination paper, as well as examples of the different kinds of questions that you may expect.

You may expect that examination questions will be similar to the questions asked in the activities in Tutorial Letter 501/2008 as well as in the assignments.

#### 4.5 Format of the examination paper

The duration of the examination is **two hours**.

The examination paper carries a weight of **100 marks**.

The paper consists of **two compulsory sections**:

- Section A : 50 marks
- Section B : 50 marks

You must do **both sections**.

**Section A** of the examination paper will take the form of **fill-in questions**. This means that you will have to answer the questions **on the paper** itself that will be handed to you (instead of in a separate examination book). After completion of the examination, you will thus **hand in** the examination paper.

**Section B** will take the form of **multiple-choice questions**. These questions must be answered **on the mark-reading sheet** that will be handed to you together with the examination paper. After completion of the examination, make sure that you **hand in both the mark-reading sheet and the examination paper**.

The **Afrikaans version of each question follows** immediately upon the **English version of the question**.

You may expect the following **kinds of questions** in the examination paper:

[After each question we give the answer to the question, as well as the mark allocation (in round brackets) as it would appear in the memorandum which is used by the markers.]

- **Short questions**

Who is the presiding officer in a case in the High Court? (1)

**Answer:** A judge (1)  
[See Study unit 12, p 190.]

- **Short discussion-type questions**

Explain the connection between "law" and "right". (2)

**Answer:** The connection between "law" and "right" is twofold: First, it is the law (which consists of various legal rules) that determines or prescribes what the content of a right is (in other words, what the powers of a holder of a right are). (1) Secondly, the law prescribes what the limits to the content of a right are. (1)

- **Problem-type questions**

John and Karel were involved in an argument. John hit Karel and Karel had to receive medical treatment. He now wants John to pay for his medical expenses. Advise Karel as to the type of action that he can institute, as well as the court where he can institute his action. (5)

**Answer:** Karel will be able to institute a civil action for his medical expenses. (1) The court in which the action will be instituted, will depend on the amount that Karel claims for his medical expenses. If the amount is not too large (less than R100 000) (1), he will have to institute his claim in a magistrate's court/lower court (1). If it is a large amount (more than R100 000) (1), he will have to institute his claim in the High Court (1). [See Study unit 10, p 168; Tutorial Letter 501/2008, p 38.]

- **"Name" questions**

Name four of the authoritative sources of South African law. (2)

**Answer:** Any four of the following five sources for (½) mark each = (2):

- 1 Legislation (½)
- 2 Court decisions (½)
- 3 Common law (½)
- 4 Custom (½)
- 5 African indigenous law (½)

[See Study unit 6, p 68.]

- **"Correct/Incorrect" questions**

Indicate whether the following statement is **correct** or **incorrect** and **give a reason** for your answer:

"The defendant is one of the parties in a civil case." (2)

**Answer:** Correct. In a civil case there are two parties, namely the plaintiff and the defendant. (2)

- **Multiple-choice questions**

**Example 1**

Zipporah owes Silas a large amount of money. She decides to deliver her horse to Silas as security for her debt. This is an example of ...

- (1) a personal right.
- (2) ownership.
- (3) a real right.
- (4) a right to performance. (2)

**Answer:** Statement (3) is the correct statement. (2)  
[See Study unit 2, pp 22-23.]

### Example 2

Sibaniso Burgher is arrested for assaulting his wife, Catherine, and their two children. Sibaniso appears in court to plead. Who will be the parties in this case?

- (1) Catherine and Sibaniso
- (2) Catherine, the two children and Sibaniso
- (3) the state, Catherine and the two children
- (4) the state and Sibaniso (2)

**Answer:** Statement (4) is the correct statement. (2)

**[Note:** Our facts deal with a criminal case. Sibaniso is accused of a crime because he assaulted his wife and two children. In a criminal case the parties are the state and the accused. Thus, the state and Sibaniso will be the parties in this case. See Study unit 11, p 186.]

All of the above kinds of questions are covered in the assignments and the activities in Tutorial Letter 501/2008. **When you study for the examination, you must work through all the assignments and the commentaries on the assignments, as well as through all the activities and the feedback in Tutorial Letter 501/2008.** This is an important part of your study package.
