SECTION A: THE LAW OF NEGOTIABLE INSTRUMENTS**QUESTION 1**

Define the following terms in the context of negotiable instruments:

- (a) Payment in due course (4)
- (b) Cheque (3)
- (c) Acceptance (3)

QUESTION 2

- (a) Explain whether X is a holder or a holder in due course, or a possessor.
- (i) A draws a cheque on B Bank in favour of "C or order". The cheque is crossed generally with the words "not negotiable" across its face. C indorses the cheque in blank and delivers it to X, who takes it in good faith and for value. (4)
- (ii) A draws a cheque on B Bank in favour of "C or order" and delivers the cheque to C. C is a minor and without the assistance of his guardian he indorses the cheque specially to X and delivers it to X, who takes it in good faith and for value. (4)

- (b) Read the following scenario and answer the question given. Your answer should include explanations.

Suppose A draws a cheque on B Bank payable to "C or order". D steals the cheque from C, forges C's signature on the back of the cheque and delivers it to E. E indorses the cheque and delivers it to X, who takes it in good faith and for value. Can X enforce payment against any of the parties? In your answer you should also explain whether X is a holder, a holder in due course, or a possessor.

QUESTION 3

- (a) Name and briefly discuss the requirements that must all be present simultaneously before a drawee bank will be protected in terms of section 58 of the Bills of Exchange Act. (7)
- (b) Name four rights that a holder of a bill has in terms of the Bills of Exchange Act. (4)
- (c) What is the effect of a special crossing on a cheque? (2)
- (d) Identify the different types of indorsements used in the following examples:
- (i) Pay Natania Lock only
(signed) *Michelle Kelly* (1)
- (ii) (signed) *Michelle Kelly* (1)

QUESTION 4

A draws a crossed cheque on B Bank in favour of "C only" in repayment of a loan. At C's request A posts the cheque to him. X intercepts and steals the cheque before it reaches C. X forges C's signature and negotiates it to D who takes it in good faith and for value. D deposits the cheque for collection in his bank account with S Bank. S Bank presents the cheque for payment to B Bank. B Bank pays S Bank in good faith and without negligence. B Bank debits the account of its customer, A and S Bank credits the account of its customer, D. (19)

- (i) Identify the specific works which are eligible for copyright protection. (2)

- (b) X, a computer programmer, worked for MIC, a computer software company. While in the employ of MIC, X wrote a program for doctors for the charging of fees called "Medfees." X made a back up copy of "Medfees" for his own use. X later resigned from MIC. X then wrote a similar computer program called "Healthfees." X made considerable use of the backup copy of "Medfees" in writing "Healthfees."
- (i) Advise MIC whether X was entitled to make a backup copy of "Medfees"? (5)
- (ii) Does "Healthfees" infringe MIC's copyright in "Medfees"? (5)

QUESTION 6

R, a Dutch company, manufactures fertilizers under the name "Triomf." Triomf is registered as a trade mark in the Netherlands. Triomf fertilizers have become well known in South Africa through advertising in agricultural magazines. S, a South African company, translated the name "Triomf" into "Triumph." S then uses "Triumph" as the trade mark for its own fertilizers. Are there any grounds under the Trade Marks Act on which R can prevent S from using the trade mark "Triumph" for fertilizers. Discuss fully. (10)
